## Resolution on Student Representation on University Search and Review Committees

**WHEREAS**, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 12,500 students; and

**WHEREAS**, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population to make sound decisions for the betterment of CSUEB students; and

**WHEREAS**, ASI represents the student body and advocates for student rights when working with staff, faculty, administrators, and government officials; and

**WHEREAS**, the Policies and Procedures of Governing Faculty Participation in Appointment and Review of Administrative Officers of California State University, East Bay addresses searches for each of the following divisions: Academic Affairs, Administration and Finance, Planning and Enrollment Management, Student Affairs, and University Advancement; and <sup>1</sup>

**WHEREAS**, ASI has written a resolution on adding students to CSUEB search and review committees 2015-2016; and<sup>2</sup>

**WHEREAS**, the California State University East Bay has conducted Chief of Police, Dean of Library, and VP of Academic Affairs/ Provost search in the 2023-2024 academic year; and

WHEREAS, CSUEB will continue to have the VP of Academic Affairs/ Provost search along with a Dean of Science, Dean of Health, and Dean of CLASS for the 2024-2025 academic year; and

**RESOLVED,** CSUEB ASI urges Academic Senate to update their Policies and Procedures of Governing Faculty Participation in Appointment and Review of Administrative Officers of California State University, East Bay to include the Chief Diversity officer position, every VP Cabinet position to require 1 Student selected by ASI, and every other administrative position to solicit input from ASI (interview panel or participating in open candidate forum); and let it be further<sup>3</sup>
